

**Bush's Manning the Grill Contest  
Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

**BY ENTERING THE CONTEST, ENTRANT AGREES TO THESE OFFICIAL RULES.**

- 1. SPONSOR:** Bush's Brothers and Company, 1016 E Weisgarber Rd., Knoxville, TN 37909 ("Sponsor").
- 2. ADMINISTRATOR:** Arrowhead Promotion & Fulfillment Co., Inc., 1105 SE 8th St, Grand Rapids, MN 55744 ("Administrator").
- 3. ELIGIBILITY:** BUSH'S MANNING THE GRILL CONTEST (the "Contest") IS OPEN AND OFFERED ONLY TO LEGAL RESIDENTS OF THE CONTINENTAL UNITED STATES AND DISTRICT OF COLUMBIA, WHO ARE 18 YEARS OF AGE AND OLDER OR WHO HAVE REACHED THE AGE OF MAJORITY IN THEIR STATE OF RESIDENCE. Employees, officers, and directors of Sponsor, Administrator and each of their respective parent entities, subsidiaries and affiliated companies (collectively, "**Contest Entities**"), as well as advertising, sweepstakes, or production agencies or partners (and their respective dependents, immediate family members, including children, spouse, parents, siblings, step-parents, step-children, step-siblings and their respective spouses, regardless of where they reside, and individuals residing in their same household at least three (3) months a year, whether or not related) are not eligible to participate or win. - 5. HOW TO ENTER:** During the Contest Period, visit [BushsManningtheGrill.com](http://BushsManningtheGrill.com) (the "Website") to complete and submit an official entry form, including the upload of your contest video explaining why you, your dad, mentor, or father-figure could use a hand "Manning the Grill" in a 30-second video. All entries must be received by 11:59 PM CST on June 28, 2023.

- 7. ENTRY CONTENT RESTRICTIONS:** Entries must not be longer than 30 seconds and must not contain material that:
- a) Violates or infringes another's rights, including without limitation, privacy, publicity or intellectual property rights, or that constitutes copyright infringement;
  - b) Promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation or age;
  - c) Contains or promotes illegal, indecent or unsafe behavior or situations, profanities or obscenities, including but not limited to use of firearms/weapons/ammunition, nudity, gambling, or pornography, or is otherwise inappropriate, indecent, profane, obscene, violent, hateful, tortuous, slanderous or libelous;
  - d) References persons or organizations without their written permission other than that of Sponsor;
  - e) Disparages any persons or organizations;
  - f) Includes threats to any person, place, business, or group;
  - g) Is in violation of or contrary to all applicable federal, state, municipal or local laws and regulations;
  - h) Contains anything that is determined to be inconsistent with Sponsor's reputation or damage or diminish the goodwill of the Released Parties (defined below in Section 11), as determined by such entities solely in their respective discretion.

Failure of any Entry to comply with the above "**Entry Content Restrictions,**" as determined by Sponsor, in its sole discretion, may result in disqualification of Entrant. Without limitation, Sponsor reserves the right in its sole discretion to disqualify any Entry that, at its sole opinion, refers, depicts or in any way reflects negatively upon the Sponsor the Contest or any other person or entity, does not comply with these Official Rules or if Sponsor receives notification about any potential infringements or breaches of law or any other reason set forth herein. Entries must be suitable for presentation in a public forum, in the sole determination of Sponsor.

- 8. Judging Criteria and Winner Selection:** From about June 29, 2023 through July 17, 2023, all eligible Entries received during the Promotion Period will be judged by members of Released Parties using the following judging criteria and percentages: Passion for Bush's Baked Beans (40%); Originality (30%) and Personality (30%) (Collectively, the "Judging Criteria"). The top twenty-one (21) Submissions with the highest scores using the Judging Criteria will be deemed Finalists, and be re-judged using the Judging Criteria, with the submission with the top score being deemed the Grand Prize winner. In the event of a tie, the Entry with the highest score in passion for Bush's criteria, will be deemed the Finalist/winner from among all tying Submissions. Potential Finalists will be contacted via email or telephone on or about July 21, 2023. THE POTENTIAL GRAND PRIZE WINNER IS

SUBJECT TO VERIFICATION BY ADMINISTRATOR AND SPONSOR'S DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE PROMOTION. Released Parties shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason, or for any entrant who changes his/her contact information. If your Submission is not selected as a potential winner, you will not receive a notification.

occupancy room and tax only), ARV \$600; game tickets and entrance to the tailgate (to take place in a location selected by Sponsor in the Knoxville, TN area at a time prior to or after the game) with Peyton for up to 10 additional guests (travel not included), ARV \$1,500, a meet-and-greet with Peyton Manning, a year's supply of Bush's Baked Beans, ARV \$200 and a Victory 3-Burner Propane Gas Grill with Infrared Side Burner, ARV \$1,000.
